


Public research body enjoying technical-scientific and regulatory independence

## ISPRA and SNPA National System for Environmental Protection (SNPA)

- Established in 2016 by law n. 132
- Composed of 19 Regional and 2 Province's Environmental Protection Agencies, under the chairmanship of ISPRA
- Workforce of over 10,000
- Ensures a detailed and diffused environmental monitoring
- Duty to provide coordinated nation-wide essential levels of technical environmental performance, also through the harmonization of the national environmental laboratories network methodologies

- Monitoring of the state of the environment and impacts, also as reporting for EU regulations
- Support to SEA Procedures
- Support to EIA Procedures
- EIA inspection and control activities
- Inspection activities RIR
- Inspection activities on noisy machines and equipment
- Declarations of conformity of machines intended to work outdoors
- Support for Ecolabel Licenses
- Support for EMAS registrations
- 4000 National plants registered in the LCP and PRTR databases
- 2400 Contacts for the ETS Register







- Opinions on wastes on decrees or administrative acts
- Reports for the EC on the recovery and recycling of priority waste streams
- Technical investigations for the recognition of consortia for the recycling of specific waste streams
- Proceedings as a verifying body for waste
- Participation in European technical committees for the adaptation of waste and circular economy regulations
- Management of dangerous substances (REACH)











As National Centre for the Waste Cycle ISPRA prepares the annual reports on the production of urban and special waste and manages the telematic cadaster

As part of the coordination activities of the **National System for Environmental Protection**, it publishes the Land Consumption Report


As a **cartographic body of the State**, it produces the official geological cartography


### **ISPRA** is part of the National Statistical System


